#### PERTH AIRPORT UPDATE

**June 20 meeting** Kym Meys, General Manager Strategy & Development at Perth Airport, will provide an update on what is happening at Perth Airport, including the New Runway Project, at the next meeting of the Guildford Association on Tuesday June 20 at 7.30pm at the Mechanics Institute in Meadow Street, Guildford.

The talk will be followed by a general meeting of the association.

All are welcome to attend.

#### **JAMES STREET CROSSING**

Work is to begin on the long-awaited James Street pedestrian crossing on May 29<sup>th</sup>. Michelle Roberts MP has lobbied for this for a long time. Cr Ian Johnson raised the issue at Council in 2015 and it was taken up by Alyssa Hayden MLA. We are pleased the new government has continued to support the need for a safe crossing at this strategic point by the railway station. The new signalised facility will greatly improve the safety of those crossing to the café strip from the train station and to students from other schools who have to cross James Street to reach the Guildford Primary School dental therapy centre.

Main Roads state that the crossing will be three metres wide with pram ramps and a pedestrian refuge in the central median. In keeping with the heritage precinct the signal poles will have a striped red and white pattern and the brick paving will be matched to the existing area. It requires the

removal of one Jacaranda tree in the central median. This will make room for the installation and maintenance of signal poles and ensure that sightlines meet current safety standards for pedestrians and road users. There will also be some reconfiguration of the on-street parking bays on the southern side of James Street.

#### **MCDONALD'S UPDATE**

The Guildford Association submitted a detailed report as part of the public comment period on this Development Application. It was noted that the development was inconsistent with the objectives of State and Local Government policies, used out of date traffic and parking data, and did not even mention the presence of the local primary school etc

At the last Association meeting a motion was moved from the floor that the Mayor be asked to hold a Special Council meeting so the officer's report could be presented to Council and the councillors could form a position on this matter. It was also requested that the community should be able to view this report prior to this meeting and before the JDAP meeting. Cr Johnson advised that the City is requesting the JDAP meeting be deferred from June until July.

We understand that the City has received 865 submissions about this proposal and a petition with 5420 signatures against the development has been lodged. A big thank you to the campaigners in the community including Claire Scanlan, Celeste de Saxe, Anita Rowell, Patsy Hocking and Bromwyn Facer. At the June 7 Council meeting Cr Ian Johnson put forward a motion to bring all JDAP reports, including the McDonald's report, before Council for a recommendation. Disappointingly, the motion lapsed as no other councillor seconded it.
